- 6. It is mandatory to display a signboard stating "Classes granted under Self-Financed principles" in the visible area of the school building for public information.
- Schools granted authorization under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 shall not be allowed to relocate to any other place in the future.
- 8. Permission is granted under the Government Resolution No. SFS/1019/Pr. No. 596/SM-2, dated 27.8.2019, subject to compliance with the condition No. 2.
- 9. Schools recognized under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 will be required to register information as a Self-Financed class distinctly in UDISE.
- 10. It is mandatory to implement the existing current rules and such rules as the government may prescribe from time to time.
