SI. The school is directed to ensure that : No.

- The total number of sections for classes 1st to 10th shall be restricted to 12 only. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and availability of class rooms of 500 sq ft and greater in dimension. The school is directed to run bal-vatika/foundation classes (I, II & III) in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
- The school is not maintaining the website properly with Mandatory Public Disclosure link having all public documents uploaded thereon at its website for access to the public. As per Board guidelines and circular no 09/2021 the school should have a functional website with all mandatory documents available on the Mandatory public disclosure link for easy access to the public on school website in compliance of Circular No: 09/2021 Date of (21 May 2021) Display of "Mandatory Public Disclosure" at Home Page in school's website under prominent icon leveled as "Mandatory Public Disclosure"). School is directed to make direct link for MPD functional and upload all documents as per board guidelines and make the compliance within 03 months on SARAS portal.
- The Composite Science Lab has not been arranged properly. Work station for the Biology section is temporarily arranged on shall benches placed along with the wall with limited instruments. School should follow the Board guidelines notified vide circular no 11/2022 and arrange the lab with proper work stations and recommended infrastructure for each section. The compliance be uploaded with videography within 03 months on SARAS portal.
- 4 Library is under stocked without separate teachers' section. School should add more books/stock on autobiographies, biographies, travelogues, essays, fiction, poetry, drama, recreational and motivational materials, encyclopaedia, yearbooks, maps and charts etc and separate teacher's section in compliance of Board guidelines and SoPs notified vide circular no 11/2022. The compliance be uploaded with videography within 03 months on SARAS portal.

- Math lab is also arranged on small tables without proper work stations. School should follow the circular no 11/2022 and upgrade the math lab with recommended work stations and infrastructure. The compliance with videography be uploaded within 03 months on SARAS portal.
- As reported by the Inspection Committee, school has not appointed the special educator. School is directed to appoint the qualified special educator and upload the appointment letter along with qualifications on the SARAS portal within 03 months.
- The CwSN facilities have not been arranged as per the board guidelines. In toilets, small towel handles are temporarily affixed in place of proepr side support bars which are not suitable and recommended as per board guidelines notified vide circular no 05/2023. Further, school building is G+6 floors and CwSN toilets separately for Boys and Girls be arranged at each floors. School is directed to make compliance strictly as per guidelines and upload the videography covering each floors on SARAS portal within 03 months.
- 8 School has appointed male member as head of the sexual harassment committee which not in consonance of the statutory provisions. A qualified female staff should be appointed as head of the committee and the compliance be uploaded within 03 months on SARAS portal.
- 9 School shall ensure the mandatory training of its teachers from the CoE, CBSE Pune and shall upload the compliance within 03 months on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to

- time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
